Legislative Report:

House passes reconciliation package; NALC action defeats two of three attacks aimed at letter carrier retirement benefits. The one remaining elimination is the elimination of the Federal Employee Retirement System (FERS) special annuity supplement, a crucial benefit for FERS-covered employees who retire before becoming eligible for Social Security at age 62, forcing you to work longer. We need to contact our senators. Go to NALC website, government affairs tab and take action.

White House releases FY2026 budget details.

The White House budget proposes eliminating steward time at the USPS.

NALC President Brian L. Renfroe called the proposal a calculated attack on their collective bargaining rights, letter carriers and the union. Once again, take action, every voice matters.

New Contract Provisions Starts July 1st

Article 8:

Added Article 8.2.D- Full time not ODL or WA have the right to refuse working past 11.5 hours. 12 hours daily with lunch and 60 hours weekly without fear of discipline.

Article 8.3- PTFs and CCAs are guaranteed at least 1 N/S day a week.

Article 8.4- Any time worked beyond daily/weekly limits will automatically be paid an extra 50%

Article 8.5 - ODL split in 3 options

Option 1: 8 hrs/day and OT on N/S day. Only 8 hours per day.

Option 2: Up to 12hrs/day but no OT on N/S day.

Option 3: Join both options.

Equitability will be done on each list separately.
