Retired Members Report:

The Social Security Administration (SSA) announced that starting February 24, 2025, the agency is beginning to pay retroactive benefits and will increase

monthly benefit payments to people who were affected by the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). Beneficiaries who are owed retroactive benefits will receive a one-time retroactive payment. This payment will date back to January 2024, the month when WEP and GPO no longer applied.

This has already started, Social Security benefits are paid one month behind, so most affected will begin receiving their new monthly benefit amount in April 2025 for their March 2025 benefit.

As of February the current COLA is 0.8%, it does not get finalized until this October.

President's Report:

Discussion of Interest Arbitration.

Interest Arbitration is set to begin March 17. Dennis R. Nolan will serve as the neutral arbitrator. The Executive Council has agreed to do an expedited arbitration process.

The Postal Service announced on February 18, that Postmaster General DeJoy has notified the USPS Board of Governors of him stepping down.

The Trump administration, and Republicans, have declared war on unions, especially Federal unions. President Trump is planning to dissolve the leadership of the USPS and place it under the control of the Commerce Department, potentially violating federal law. The Postal Service's bipartisan board is preparing to fight the order, retaining outside counsel and threatening legal action.

House Budget Plan may put Federal Employee Benefits on table for cuts 2/19/2025. The article describes a House Budget Plan that could lead to cuts in federal employee benefits. The plan proposes all FERS employees to contribute 4.4% of their salary towards their retirement benefits. Additionally, the plan suggests ending the annuity supplement for those who retire under FERS before 62.
