# **Legislative Report:**

Congress to cut letter carrier retirement benefits. As part of the budget reconciliation process. These proposals include:

Increasing the Federal Employees Retirement System (FERS) contribution rate for existing employees up to 4.4%.

Cutting retirement benefits by eliminating the FERS special annuity supplement Reducing annuity payments by calculating a retiree's annuity based on their high-five salary average instead of three.

NALC completely opposes this measure, NALC President Brian L. Renfroe said. We see this for what it is - a pay cut for letter carriers and all federal employees. Taxpayers don't fund the Postal Service or letter carriers' retirement benefits. We will continue fighting like hell against these attacks to preserve the retirement benefits that we've earned.

Please take action, this is our future, we have to let our voices be heard.

Steiner's history of union-busting and potential harm to the USPS pose a threat to postal workers and rural communities.
