Retired Members Report:

The Final 2026 retiree COLA calculation will be announced any day now. The COLA will be the number used for your 2026 pension check.

The last projection was 2.8% for CSRS and 2.0% for FERS.

President's Report:

In February the current administration was threatening to move the PO into the Dept. of Commerce. Thanks to the action of our National Headquarter, our President Brian Renfroe and everybody else's support, we were able to take care of it.

The Trump administration issued executive orders in March and August of 2025 to end collective bargaining rights for workers in numerous federal agencies.

Federal unions have filed multiple lawsuits challenging the executive orders. As a result, the situation is not final due to the ongoing legal and legislative challenges.

We have to take action and be vigilant, make a phone call, send a text, email to our congress and senators. A united front is a strong front.

Congress has the last say to what happens at the Post Office.

NALC has initiated two national-level interpretive disputes under Article 15, Section 3.F of the National Agreement.

The first dispute concerns the Postal Service's refusal to comply with the June 30, 2025 national-level award by Arbitrator Margo Newman, known as the "NACI Award" challenging the removal of an employee terminated due to an unfavorable National Agency Check with Inquiries report.

The second dispute centers on the arbitrability of grievances appealed to Step B teams.
