## Regulations for Training & Services from the 01.05.2022

**Chapter 1. – General Dispositions :** The present regulations are to facilitate the most comfortable practice of the riding sport, promote a good social environment, and the peaceful and necessary coexistence between clients, employees, and horses.

**Article 1:**"K.K.Hiperion" is managed through his board call "the board" appointed by the president of the club, dictates this rules with the intent that all users of the facilities have the most commodities for the exercise of their sport, trying that the horses of are perfectly taken care of on all possible aspects. These rules are fore set for the action between the club and the users of the Facilities.

At this effects are included:

- a) Clients that are in any sort of contract or contacts with the club
- b) Professionals authorised, that will be working at the facilities
- c) The employees of the Club, and any other employee working at the Club whether they have been hired independently or not.
- d) Instructors & trainers of the Club
- e) Members of the Club
- f) In general any visitors from the club

#### **Article 2-. General Principles**

The general principle is to develop the coexistence & compliance of all individuals that ought to follow the regulations written here. In this manner, being part of the Club means we are all conscious, ready to follow & observe the rules with outmost fidelity & generosity

#### Article 3-. Use of the Facilities & Services

All individuals that respect the schedules established by the board will have access to the use of the facilities excluding the "privet" locals or areas designed by the panel "Privet". The scheduled established is the following, although it may change at the board of the club convenience.

#### **DEPARTMENT DAYS TIMES**

Visiting, Riding or Training Tuesday – Sunday following individuals reservations

Any other times, access to the club should be approved or organised by the board.

Local nominated by "Privet" will be reserved for the members of the board and any access by others should be confirmed by invitation from one member of the board

Riding area can be used only for riding, for any other purpose the access will have to be confirmed by the board.

It's completely forbidden to use or install any cameras in any part of the club without the special written consent of the president of the club.

#### Article 4-. Rights & duties of clients

Rights: Visitors invited from clients are welcome if they have no actions to or around the horse and/or the rider and if they respect and follow the rules of the club.

Duties: a)To follow and make follow his visitors the rules and regulations of the club, and any other rule that

#### comes from the board.

- b) Not give, or share the rights given to the user by the board
- c) Comply with the obligation to pays the club invoices in anticipation
- d) Cars are only to be driven in the parking lot, and parked in that designated area e) Riders must use certified cloths and protections during riding activities

**Article 5-.** Any client that is to be in any of the following situations will risk the right of use and in general the definitive expulsion of the club from them self and them visitors, in this case no refund of any kind can apply.

- a) Not paying any open bills or membership fee in anticipation following the limitation dates on bills
- b) Resignation of the client from any activities
- c) Revoked from a activity or forced out from the club by one of the board members
- d) Taking pictures, filming, installing or using cameras in or in direction of any parts of the club taking any situation in the club without the agreement of the president of the club.

#### **Article 6-.** Responsibility of the club & employees

The club at all times will keep facilities in good condition for the practice of the Equestrian Sport except when the harm is done by causes out of the control of the board.

Club will be presumed exempt of responsibility in the following cases:

- a) Lost or steal of objects left by clients, user or owners in any areas of the facilities
- b) Of any feed, equipment or accessories in case of fire, steal, flood, or another cause of higher forced.
- c) Of any act, or accident that any groom may cause or suffer
- d) Of any injuries or deterioration due the non respect from the client of any clubs rules or orders from any members of the board or employees from the club.

#### Chapter 2. Organisation of the work place

This is any member of the board of the club, they are individually the one who are in charge of directing the employees of the Club but also in charge of all operations, organisation, logistics and execution of the work or necessary maintenance.

In particular:

- a) Organises the functioning & cleaning of the club & facilities
- b) Establishes the control of in & out, movements of horses, and equipment used
- c) Will check what horses are ridden by which client, or authorised personnel, and proper riding equipment
- d) All in all, they are persons who follow and enforce the rules & regulations of the Club

#### Article 7-. Stable Hand

There will be allowed one kinds of grooms, those hired by K.K.Hiperion. They will be there to satisfy the requirements of the board.

Article 8-. Remarks about the way of working in the barn area

- a) No modifications that compromise the structure of the building, or stall are allowed
- b) None can ride a horse that is not allowed by the board or the club's employees
- c) None can mistreat any employee of the facilities
- d) No vehicles allowed anywhere but in the parking area
- e) No trot or canter anywhere that is not in the riding arenas
- f) No smoking allowed in any buildings from Club Hiperion
- g) No horses free out of the area provided for this purpose

#### Chapter 3-. Instructors: Classes & Horse tack-up

Article 9-. The Club will have its own qualified instructors to teach at the club.

They will be in charge of the lesson and any needed riding or training the horse may need.

**Article 10-.** They will always be under the orders of the board of the Club, and everything that is relation to the instruction, schedules & prices.

**Article 11-.** Outside trainers may come if approved by the board to train at certain hours and after paying in advance the monthly trainer fee of 2000 Kn. They are subject to all rules & regulations while at the club and respond to the board.

**Article 12-.** Using of Clubs areas by Agronomy Faculty is agreed by a separated Contract but during them visit at the club the people from faculty will have to follow those rules.
