REQUEST

In regards to Lithuania missing a deadline to implement an EU directive

2025-01-16 Vilnius

We, the Young Market Participants Association (Lithuanian – Jaunųjų Rinkos Dalyvių Asociacija; hereinafter – JRDA), are writing to you, the European Commission, in regards to the implementation of the EU directive 2020/285 in Lithuania's national law.

Unfortunately, as the governments changed and ambitions ruled the thoughts of our previous coalition, the project to change the respective law was submitted too late. On August 13th, 2024 a draft was submitted for review by the relevant ministries and other parties. On August 30th, 2024 the review deadline was reached and the Ministry of Finance had to take all of the suggestions into account. On November 12th, 2024 a new project was registered by the ministry.¹

On November 25th, 2024 the Government office's legal group issued a conclusion, which consisted of 15 notes for fixing the draft². All but two of the requests were to fix syntax, terminology, and consider to make some parts of the new law more concise (they issued specific recommendations). They also mentioned that it is mandatory to number pages. In Article 13 they asked to reconsider the proposed law's date of entry into force, which was adequately listed as January 1st, 2025. They also added a comment that the Lithuanian government had not asked for an expedited review and voting.

For us, JRDA, representatives of young adults seeking to do business in Lithuania, our government's actions constitute gross negligence in regards to supporting small businesses and providing us more options to do business abroad, especially in the European market, on equal grounds. This is further reinforced by the fact that it's almost the end of January and we do not even have a revised draft of the law.
