

## The Commonwealth of Massachusetts AN INITIATIVE PETITION FOR A LAW

Under Article XLVIII of the Amendments to the Constitution of the Commonwealth

## **SUMMARY**

This proposed law would declare the policy of the state to be that zoning and land use are matters of local control that lie primarily but not exclusively with cities and towns. This proposed law would also prohibit the state from compelling, coercing, or incentivizing cities or towns to adopt or not adopt

FILING DEADLINES. Initiative petitions must be submitted to local election officials for certification of signatures no later than 5 p.m. on Wednesday, November 19, 2025. Local election officials must complete their certification no later than December 1, 2025. Thereafter, initiative petitions containing certified signatures must be retrieved by petitioners from the local election officials and then filed with the Elections Division, Office of the Secretary of the Commonwealth, One Ashburton Place, Room 1705, Boston, MA, no later than 5 p.m. on Wednesday, December 3, 2025.

particular zoning policies. This proposed law would repeal any law inconsistent with this prohibition, except certain state laws that establish the permitting and appeal process for the construction of low- or moderate-income housing.
