Mike's replacement, Chris Houck, takes over as Park Manager near the end of August. Most recently, Chris was Assistant Park Manager at the French Creek State Park Complex in Bucks and Chester Counties. And just like Mike, one of Chris' first responsibilities in his new assignment will be oversight of the installation of a trail bridge by the Friends of Pine Grove Furnace State Park.

Pennsylvania Outdoor Corps

Staff and volunteers have been working hard to keep park hiking trails maintained. In June we were very fortunate to have the assistance of members of the Pennsylvania Outdoor Corps. A small but enthusiastic crew spent several weeks in Pine Grove Furnace State Park fixing a couple troublesome spots on Mountain Creek Trail, uncovering part of a historic feature on Koppenhaver Trail, pulling invasive plants, and starting a new pathway to connect the Furnace Stack with the Fuller Lake parking lot.

DCNR's Pennsylvania Outdoor Corps is a ten-month program for young adults ages 18-25, offering work experience, job training, and environmental educational opportunities. The Outdoor Corps works in state parks throughout Pennsylvania on projects such as habitat enhancement, tree planting, trail restoration, invasive species management, and light construction.

Trail Bridge Update

A permit for the new Koppenhaver-Mountain Creek Trails connector bridge was approved by the Department of Environmental Protection. Park staff are now preparing a site along Old Railroad Bed Road for installation of the 50-foot prefabricated steel bridge, hopefully in October. It will connect the two primary trails between Laurel and Fuller Lakes to create a trail system across the park.

The project is being funded by the Friends of Pine Grove Furnace with the support of two grants totaling \$70,000 from the Cumberland Area Economic Development Corporation and the Cumberland County Land Partnerships Grant Program.

Summer 2020

The relatively dry summer and COVID-19 have encouraged a lot of people to get outdoors and enjoy Pennsylvania's free state parks and state forests. According to Cindy Dunn, Secretary of DCNR, park attendance is way up in 2020. In May alone, attendance reports show 5.8 million visitors statewide compared to 4.2 million in May 2019. That is an increase of more than 1.6 million for just one month—a 36 percent increase. In some parks located near urban areas, visitation has doubled! Like the rest of the state, Pine Grove Furnace State Park has seen an increase: *monthly attendance is up by 30–50 percent over last year.*

The first impact of COVID-19 on our park was increased trail usage early this spring as people headed outside for exercise. Once the family campground opened on Memorial Day weekend, it has been full every weekend. In addition, there have been more weekday camping reservations as people look for different ways to spend their vacations with minimal exposure to others. Meanwhile, picnic areas and our two beaches have been especially crowded on weekdays as opposed to weekends as people adapt their summer schedules to life during a pandemic.

There is no question that COVID-19 has presented many unexpected consequences. For parks, it brought out a lot of first-time users seeking safe activities outside their homes. Just by looking at license plates it is clear that many are from out of state.

These new visitors keep the rangers busy educating them on basic rules such as pick up your trash, keep your dog on a leash, no alcohol, and please do not feed the bears! Unfortunately, another consequence of increased visitation has been the amount of trash generated and that, along with new cleaning protocols required for everyone's health, has increased the workload of park maintenance staff.
