









- To empower young women by fostering self-esteem, selfconfidence, and resilience through workshops, mentoring, and creative activities.
- To equip youth workers with a comprehensive understanding of domestic violence, including its causes, effects, and available support systems.

- To enhance the skills of youth workers in providing appropriate and effective support to young women who have experienced domestic violence.
- To develop a toolkit and training materials for youth workers, providing them with practical strategies and resources to support young women in their communities.

Activities:

- Kick-off meeting in France.
- International Training in Romania.
- Creative Therapeutic Activities in Turkey.
- Advocacy in Lithuania: Conference on domestic violence's impact on young women and youth workers' role.





- Public awareness campaigns on domestic violence, creating referral networks with local organizations.

ROMANIA

According to the data of the General Inspectorate of the Romanian Police:

In 2020, approximately 27,000 cases of domestic violence were reported, and 80% of the victims were girls and women.

In 2021, there were approximately 30,000 incidents of hitting or other forms of domestic violence. Tragically, 38 women and two girls were killed by their partners or family members. 237 women and girls were victims of domestic rape, and 392 cases of harassment were reported.

The situation did not improve in 2022 when 42 women and 4 children lost their lives due to domestic beatings and abuse. Nearly 40,000 women and 9,000 children fell victim to domestic violence that year.

These figures underline the scale and continuing seriousness of domestic violence, highlighting the urgent need for firm action to protect victims and combat this scourge at the national level.







TURKEY

The situation of domestic violence in Turkey remains critical, with systemic issues in protecting victims and holding perpetrators accountable. Despite legislative measures and the establishment of institutions like the Violence Prevention and Monitoring Centers (ŞÖNİM), enforcement is inconsistent. For instance, while preventive and protective orders are available, their effectiveness is undermined by inadequate enforcement and monitoring. Many women remain vulnerable to ongoing abuse even after obtaining court orders, and some have been killed despite these measures being in place.

Turkey's withdrawal from the Istanbul Convention in 2021 has further complicated efforts to combat domestic violence. This convention was a key framework for promoting gender equality and ensuring comprehensive protection for victims of domestic violence. The government's current approach, influenced by conservative and paternalistic views, does not fully address the root causes of gender-based violence. As a result, legal protections are often insufficient, and economic dependence on abusers due to low female workforce participation exacerbates the problem.

The failures of the justice system are evident in numerous tragic cases. In many instances, officials fail to take appropriate action or conduct thorough risk assessments, leading to preventable deaths. Public pressure through social media has sometimes spurred action, but this highlights the gaps in the official response. Greater accountability and cooperation with women's rights organizations are crucial for meaningful progress in protecting victims and preventing domestic violence in Turkey.





FRANCE

In France, a woman dies every 2 days as a result of feminicide. The figures for violence against women have been rising in recent years. There are several reasons for this, including the economic crisis and the Covid period, it should also be noted that the various information and awareness campaigns have enabled women to speak out. For a long time, violence against women remained hidden, ignored as a fact of society and an issue of public health and safety. It was not until the 1990s that the first surveys on the subject were carried out and their scale revealed. This violence can range from moral harassment to physical and sexual assault. In 2022, 118 women were killed by their partner or ex-partner, and 267 women were victims of attempted femicide. On average, every year, around 321,000 women report having suffered physical, sexual, psychological or verbal violence at the hands of their partner or ex-partner. Sexual violence is also on the rise, with 87,000 women reporting sexual violence in 2022, an increase of 13% compared to 2021. What's more, the data shows that more than half the victims of sexual violence are minors, and 83% of them are girls. The phenomenon has since been taken into account by existing policies. The revelation of the scale of violence against women, made possible by the surveys conducted on this subject, has led to the implementation of national policies to combat such violence.





FRANCE

France's current policy on combating violence against women is based on three main texts: the Istanbul Convention, which sets out a general framework, the law for real equality between women and men, which makes it possible to prevent violence, protect victims and punish perpetrators, and the 4th Interministerial Plan for preventing and combating violence against women, which organises the deployment of the main actions over the period 2014-2016. Because violence against women differs from other forms of violence in a number of ways (proximity between the victim and the aggressor, the phenomenon of control, fear of not being believed, material constraints or constraints with regard to children that prevent the victim from disclosing the violence, etc.), it is still a taboo subject. Even though the number of complaints of domestic violence has risen in recent years, the percentage of women who prefer to remain silent is still very high. So beyond policies to combat violence against women, work on the around involving all the professional players in society is necessary. The rate of violence against women can only be reduced by raising society's awareness and creating an environment of trust where victims can express themselves without fear and where they know they will be looked after. The mobilisation of the authorities, associations and civil society is essential if we are to make further progress towards a safer and fairer society for all women.



LITHUANIA

Domestic violence remains a pervasive issue in Lithuania, with more than 56,000 reports of domestic violence registered in 2023, indicating the severity and frequency of this problem across the country. The cities of Vilnius and Kaunas, being among the largest, have seen significant numbers of these cases, reflecting broader national trends. The legal measures, including the 2021 amendments to the Law on Protection from Domestic Violence, have introduced protective warrants that require the abuser to vacate the home if they pose a risk. These warrants are crucial in providing immediate safety, and in just one weekend following the introduction of these amendments, the police issued 147 warrants.

Despite these efforts, Lithuania's non-ratification of the Istanbul Convention underscores ongoing challenges in effectively addressing domestic violence. The debate around this ratification reflects deep-seated views on gender roles and violence, complicating the adoption of international agreements aimed at protecting women from violence. As of now, discussions continue in Lithuanian political spheres, especially concerning the convention's focus on gender-specific protections which some argue might exacerbate gender disparities rather than resolve them. These political and social dynamics illustrate the multifaceted nature of combating domestic violence in Lithuania, revealing the necessity for both robust legal frameworks and broad societal changes.

SECTION B - DESCRIPTION

Target group / Beneficiaries:

Women and children victims of violence, mainly domestic violence.

The main objectives:

- Welcome, listen to and guide women and their children who are victims of violence, anonymously and free of charge
- Help them to prevent and recover from emergencies (emergency accommodation services)
- Help them find alternative accommodation and reintegrate into society and the workplace
- Guide them through a network of specialized professionals who are aware of the issue
- Raise awareness and inform the public about violence against women, its origins and the forms it can take





Experts/Staff:

SOS Femme Solidarité is organized as an association, headed by a president, an executive committee and departments with specific functions such as psychological support, victim support and education. These departments are staffed by professionals in the field.

The description of the practice (Up to 10 sentences):

Women and children victims of violence, mainly domestic violence.

Methodology/Didactic tools:

- Methodology of the welcome center: The welcome center works
 with a trained team that welcomes women victims of violence with
 or without children, with or without an appointment. It also has a
 telephone line which victims can call. It is supported by a multidisciplinary team and a network of specialized partner
 professionals.
- Methodology of Accomodation centers: Thanks to a strong partnership with public and private social landlords throughout the Bas-Rhin region (in particular the Strasbourg Eurometropolis), the Flora Tristan Center is able to provide apartments for abused women and their children. However, the Centre does not simply offer accommodation, but rather comprehensive support over a maximum period of 18 months, in contact with a multi-disciplinary team made up of specialized educators, a social worker, a social and family economics advisor and a psychologist
- Methodology of Training and Awareness: To change the way
 people look at the status of women and the violence they suffer,
 the association organizes training courses for professionals,
 symposia for local associations and awareness-raising campaigns
 for schoolchildren, students and teachers.

Methodology/Didactic tools:

A network of partnerships with state bodies and other associations is necessary for the operation of the association, in particular for the telephone hotline and the provision of accommodation for victims.





SECTION C - CONCLUCION

Conclusion:

Through its work with women, the association has several branches in different regions of France, helping women and children who are victims of violence.

Today, the association has more than 100 accommodations spaces devoted to women and their children who are victims of violence. They also receive more than 2,500 requests every year, in-person and on the phone, through the Regional Day Care Center. SOS is a model of effective women's aid organization, enabling women to call for help in complete discretion. Its methods not only help women, but also enable them to regain their self-esteem and move forward. Through its training courses, the association also helps to prevent violence against women.

SECTION B - DESCRIPTION

Target group / Beneficiaries:

Women victims of rape

The main objectives:

- Fight against rape within or outside the family, and take action against all forms of sexual violence and aggression.
- Speak Up for victims, whatever their sex, age, nationality, religion or sexual preference, in order to break the silence that surrounds sexual violence and still too often makes the victim the guilty party.
- Contribute to individual and collective awareness of what rape is: a crime rooted in inequality between women and men.
- Carry out studies based on callers' testimonies to raise awareness of the realities of sexual violence.
- Participate in building a society based on equality between women and men and recognition of their own identity and dignity.





Experts/staff:

CFCV is an association headed by a president, whose board members are other associations also working for women's rights, family protection or are in the social field.

The description of the practice (Up to 10 sentences):

- The Hotline: A telephone help line for rape victims.
- Discussion groups that enable women who have been victims of rape and/or sexual assault to rebuild their lives together.
- Accompanying Trials: CFCV has a network of partner associations and volunteers to provide support and solidarity for isolated victims during the trial of their attacker(s).
- Professional training trains professionals and activists in caring for rape victims.
- Information tools: The association regularly publishes statistical studies, information and access to rights documents on his website.
 It also relays the work of his partners to provide with as much information as possible.

Methodology/Didactic tools:

- Methodology of hotline: A toll-free telephone line for victims
- Methodology of discussion groups: These are closed groups lasting 9 to 12 months where the victims can rebuild theirselves together.
- Methodology of accompanying Trials: For isolated victims, the association has a network that can accompany them to court.
- Occasionally, the CFCV can also take legal action on behalf of one or more victims.
- Methodology of training: This training is provided by certified professionals whose aim is to learn how to prevent and identify all forms of aggression against women, and also to learn how to support them.
- Methodology of information: The association's website regularly publishes information to inform and warn women of the different types of aggression they may face.



SECTION C - CONCLUSION

Additional materials / Equipment needed:

Listening to victims through various channels and with the support of partner associations

Conclusion:

The association does a lot of work with rape victims through these listening channels and training materials. It also implements rape prevention tools for the general public, through awareness-raising campaigns and partnerships with other women's aid associations.

Target group / Beneficiaries:

Women and children victims of violence or any other violation of their rights

The main objectives:

The national federation GAMS is committed to combating all forms of violence against women, teenage girls, and to promoting maternal and child health among immigrant and immigrant-origin populations. It is particularly active against female genital mutilation, forced and/or early marriage, and other traditional practices harmful to the health of women and girls

Experts/staff:

GAMS is made up of regional associations that comply with the federation's statutes.





The description of the practice (Up to 10 sentences):

It aims to facilitate the development of the activities of the Regional Associations and/or Departmental Associations it groups together, by making its services available to them.

Raises awareness of these harmful practices among the public (PMI, middle schools, high schools, planning centers, etc.), and provides personalized welcome,

Help and support for girls and women threatened by or victims of these practices. Reception can be provided by professionals who speak local languages and can conduct intra-family mediation.

Initial and ongoing training for social, medical and educational professionals; technical advice for social, health and education professionals; the provision of a specific documentary collection; participation in discussion forums (symposia, seminars, conference-debates, etc.).

Methodology/Didactic tools:

- Training on Female Genital Mutilation
- Forced Marriage Training
- Awareness-raising material on female genital mutilation
- Publication of a guide for elected representatives, listing existing legal tools against harmful traditional practices such as polygamy and forced marriages
- Logistical support for regional and departmental associations

Additional materials /Equipment needed:

GAMS works hard through its member associations to combat violence against women.

SECTION B - DESCRIPTION

Target group / Beneficiaries:

15 women youth workers.

The main objectives:

Provide comprehensive training on domestic violence for youth workers to enhance their capacity to support and advocate for young women affected by domestic violence, covering various aspects including causes, effects, support services, and trauma-informed care, empowering youth workers to recognize signs of abuse, offer appropriate referrals, and provide ongoing support, ultimately contributing to survivors' healing and well-being.

Experts/staff:

Psychologists or counselors specializing in trauma-informed care, trainers with expertise in domestic violence awareness and prevention





The description of the practice (Up to 10 sentences):

The practice involves the development and implementation of a comprehensive 1 day training program for youth workers focused on domestic violence. The program covers various aspects of domestic violence, including its causes, effects, dynamics, and available support services.

Day:

Morning Session (9:00 AM - 12:00 PM):

Introduction to Domestic Violence (1 hour): Overview of domestic violence dynamics, trauma-informed care principles, and recognizing signs of abuse.

Crisis Intervention Techniques (1 hour): Training on crisis intervention strategies, de-escalation techniques, and safety planning.

Legal and Ethical Considerations (1 hour): Understanding legal obligations, ethical considerations, and confidentiality when supporting survivors.

Break (15 minutes)

Interactive Case Studies and Role-Playing (1 hour): Small group discussions, case studies, and role-playing scenarios to apply knowledge and skills.

Afternoon Session (1:00 PM - 4:00 PM):

Supporting Children and Families (1 hour): Training on the impact of domestic violence on children, strategies for supporting families, and community resources.

Cultural Sensitivity and Diversity (1 hour): Discussion on cultural considerations, inclusivity, and providing accessible support.

Evaluation and Wrap-Up (1 hour): Feedback session, evaluation of the training program, concluding remarks, and next steps for ongoing support and professional development.





Methodology/Didactic tools:

- 1. Interactive training sessions

- 3. Practical skills-building activities

Experts/staff:

Skilled workshop facilitators, trained advocates for domestic violence survivors.





The description of the practice (Up to 10 sentences):

The "Holistic Empowerment Workshops" are carefully crafted sessions designed to provide young women affected by domestic violence with a supportive and nurturing environment for healing and growth. Led by experienced facilitators and mental health professionals, these workshops integrate various therapeutic modalities, including art therapy, mindfulness practices, and group counseling sessions.

- 1. Art Therapy (1 hr): Participants express emotions through creative mediums, aiding in emotional processing and self-expression.
- 2. Mindfulness (30 mins): Guided exercises promote calmness and stress reduction, fostering emotional regulation.
- 3. Group Counseling (1.5 hrs): Facilitated discussions offer peer support, empathy, and community building.
- Psychoeducation (1 hr): Educational sessions empower participants with knowledge on abuse recognition, healthy relationships, and self-care.
- 5. Self-Empowerment Exercises (1 hr): Interactive activities build assertiveness, confidence, and communication skills.
- 6. Resource Connection (30 mins): Facilitators provide information on local support services for ongoing assistance.

Methodology/Didactic tools:

- 1. Interactive Workshops: Engage participants through hands-on activities, discussions, and group exercises to promote active learning and participation.
- Case Studies: Present real-life scenarios related to domestic violence to stimulate critical thinking, empathy, and problemsolving skills among participants.
- 3. Role-Playing: Encourage participants to enact various roles to understand different perspectives, practice communication skills, and explore potential solutions to challenging situations.
- 4. Multimedia Presentations: Utilize videos, slideshows, and multimedia resources to enhance understanding, reinforce key concepts, and provide visual aids for diverse learning styles.
- 5. Reflection and Sharing Circles: Facilitate open discussions and reflective exercises to encourage personal insights, emotional expression, and mutual support among participants.





Additional materials /Equipment needed:

- 1. Flipcharts and Markers: For brainstorming sessions, note-taking, and visual aids during presentations.
- 2. Laptop and Projector: To display multimedia presentations, videos, and slideshows during workshops.
- 3. Art Supplies: Including paper, colored pencils, markers, and other materials for creative expression activities.
- 4. Printed Resources: Handouts, pamphlets, and informational materials on domestic violence, support services, and empowerment resources.
- 5. Role-Playing Props: Costumes, props, or role cards for interactive role-playing exercises.

Conclusion:

In conclusion, the holistic empowerment workshops provided a tailored approach to addressing the needs of young women who had experienced domestic violence. By offering a safe and supportive environment for healing and growth, these workshops empowered 10 women with some of them experienced domestic violence to reclaim their sense of self-worth and resilience. Through interactive activities and discussions, participants gained valuable skills, knowledge, and resources to navigate their journey towards healing and empowerment. The workshops not only aimed to equip young women with the tools they needed to thrive but also provided youth workers with the necessary training and support to effectively advocate for and assist these individuals. By fostering collaboration between participants and facilitators, the workshops created a sense of community and solidarity, enabling participants to support one another and build lasting connections beyond the sessions.

10-15 youth workers

The main objectives:

We want to teach 10-15 youth workers from Romania how to issue a protection order when their safety is at risk and what are the legal terms for issuing this document, but also to raise awareness about the victims' legal rights.

Experts/staff:

Trained police officers, social workers, lawyers, psychologists





The description of the practice (Up to 10 sentences):

This practice provides a step-by-step guide for young women on how to apply for a restraining order against their abuser. Includes information on required documents, legal procedures, deadlines and institutions involved. It also prepares the participants emotionally and advises them on personal safety measures. Interactive practices recreate real scenarios to practice applying.

Participants will learn the following topics from the qualified staff: 1. What is a protection order?

- 2. How many types of protection orders are there?
- 3. "I have no witnesses!", how can I prove it?
- 4. Who issues the protection order?
- 5. How long does it take to issue a protection order?
- 6. What measures can be taken through the protection order?
- 7. What happens if the protection order is not followed?
- 8. Do I need a lawyer for a protection order?
- 9. How much does a lawyer cost for a protection order?

Methodology/Didactic tools:

Interactive workshops, simulations, individual counseling, video materials

Additional materials /Equipment needed:

Training room, video projector, typed forms, informative brochures

Recommendation and guidelines:

Involve police officers and lawyers for up-to-date information.

Target group / Beneficiaries:

Youth worker, Women survivors of domestic violence

The main objectives:

Psychological rehabilitation and socio-professional integration of survivors. Development of economic independence.





Experts/staff:

- 1. The social worker, who is usually the case manager (if he has the necessary training);
- 2. The psychologist (usually in a specialized department / service DGASPC);
- 3. The doctor (usually active in a specialized DGASPC service) or other specialists in gynecology, obstetrics, psychiatry, etc.
- 4. The policeman. Depending on the type of case, he may work with one or more police officers

from the following structures: Criminal investigations, public order (police and police stations), analysis,

prevention and research, investigation and combating organized crime and police officer who is

designated member for the Commission for Child Protection).

- 5. The lawyer (usually the lawyer belonging to DGASPC).
- 6. In addition to team members, we can also involve other professionals (teachers, forensics, therapists, officers, probation officers, lawyers, priests), probation officer; lawyers Priests).

The description of the practice (Up to 10 sentences):

- 1. Identification, reporting, initial assessment and recording of cases of victims of family violence
- 2. Detailed assessment, comprehensive and multidimensional situation of victims of domestic violence and a their families and the alleged perpetrator / criminal
- 3. Planning for specialized services and supports and other interventions needed to rehabilitate victims of domestic violence, including services or interventions for the family and the alleged offender/perpetrator.
- 4. Provision of services and interventions: supporting victims of domestic violence and families in obtaining and using the necessary services and initiating, where appropriate, legal proceedings.
- 5. Monitoring and periodic reassessment of progress, decisions and specialized interventions.
- 6. The final stage or final stage of the Service and specialized interventions, post-service monitoring and closing cases.



Methodology/Didactic tools:

The multidisciplinary and inter-agency team intervenes in both assessment and service delivery specialized. There is no standard formula when it comes to team composition based on objectives.

Evaluation or intervention - but there are several categories of professionals that are part of the composition mandatory minimum.

Additional materials /Equipment needed:

Spaces for counseling/courses, didactic materials, Entrepreneurial courses.

SECTION C - CONCLUCION

Conclusion:

Based on a detailed assessment report, the case manager develops a rehabilitation plan and/or social reintegration for victims of domestic violence. The plan is developed in collaboration with the team multidisciplinary. The services in this plan are addressed to both adult victims of domestic violence and the family and the alleged offender / perpetrator.

Recommendation and guidelines:

Involve survivors in program design but offer mentorship and the possibility of economic independence after program completion.
