#Walk/Whoa may not cross-over to Walk/Trot. One adult may be in the ring with the Walk/Whoa participant.

\*Walk/Trot 13 & Under may not cross-over to Walk/Whoa or WTC classes.

**Ranch Class Exceptions:** Proper tack and dress code required. NO SILVER, NO BLING. Classes are judged accordingly but a waiver for hoof black and banding rules to allow rider to participate in our other classes. Ranch Rail Pleasure entries MAY NOT cross-over into English/Western Pleasure classes and vice versa.
