This contract (the "Agreement") is entered into between Lana Leguía (hereinafter referred to as the "Seller," "We," or "Our") and _____ (hereinafter referred to as the "Buyer," "You" or "Your") on _____ (the "Effective Date").

HEALTH GUARANTEE

The Seller guarantees that, to the best of their knowledge, the dog is in good health at the time of sale. A licensed veterinarian has examined the dog and found it to be free from any known diseases or illnesses. The dog has also undergone all the necessary vaccinations, deworming, and other required health preventative measures. The Dam and Sire of the dog has undergone the recommended health screenings as recommend by the Siberian Husky Club of America including but not limited to hip and elbow dysplasia screening through OFA, ACVO annual eye examinations, and genetic testing for SPS1 and SHPN1. The Seller agrees to provide a health record with vaccinations, deworming and parent health screening information to the Buyer. The health guarantee is valid for 1 year from the date of purchase. During this period, the Buyer is strongly encouraged to have the dog undergo a general health examination by a licensed veterinarian at the Buyer's expense. If the licensed veterinarian determines that the dog is suffering from a serious health issue, the Buyer should notify the Seller immediately and provide written records of the veterinarian's findings. In the event of a serious health issue, or life-threatening genetic condition the Seller reserves the right to seek a second opinion from a veterinarian of their choice to confirm the dog's condition and diagnosis. The Buyer agrees to cooperate with this process. If confirmed by a licensed veterinarian that the dog has a life-threatening health issue or genetic condition the dog is eligible for return. The Buyer may return the dog for a full refund or exchange it for another dog of similar value, if available. Any difference in pricing will be paid for by the Buyer or returned by the Seller, as applicable. This health guarantee does not cover minor health issues or conditions.

BREEDING

The Buyer may not use or allow the use of the dog for breeding purposes unless the Seller provides written consent to lift this restriction, and this may include additional terms and conditions. If no such exception is agreed upon your dog registration with the AKC will be limited. You will not be able to register puppies produced. In the event that the Buyer allows the female or male dog to be mated whether purposefully or accidentally, a penalty of fifteen thousand (15,000) dollars will be enforced in court. Buyer is responsible to ensure that all persons residing with the Buyer's home understand and abide by the purchase agreement.

CLUB REGISTRATION

The Seller shall provide the Buyer with the required registration papers for the dog, if applicable. These registration papers will provide information about the dog's pedigree and lineage, which may allow for individual registration with the relevant kennel club or breed registry. Limited registration allows the Buyer to register the dog with the American Kennel Club and compete in all performance AKC events. You cannot compete in conformation events or register litters on a limited registration.

MICROCHIPPING

The Seller confirms that the dog has been microchipped with a unique identification number. The Seller's contact information along with the Buyer's contact information will remain on the microchip registration for the lifetime of the dog. The Buyer acknowledges receipt of all the necessary microchipping information. The Buyer is responsible for maintaining accurate and up-to-date contact information with the microchip registry to ensure that the dog's identification is current.

VETERINARY CARE

The Buyer agrees to ensure that the dog receives all the necessary vaccinations and healthcare, as per the recommendations of a licensed veterinarian. The Buyer also agrees to follow the recommended deworming schedule provided by their veterinarian. The Buyer is responsible for all costs associated with vet consultations or treatment.

TRANSFER OF OWNERSHIP

Upon full payment of the purchase price, the Seller agrees to transfer ownership of the dog to the Buyer. If the Buyer wishes to transfer the ownership of the dog to a third party, the Buyer must obtain the Seller's written consent.

RESPONSIBLE OWNERSHIP

The Buyer commits to ensuring the dog receives proper care. This includes but is not limited to a safe and clean living environment, fresh water, food that meets the dog's nutritional requirements for its breed and age, and shelter from extreme weather conditions. The buyer also agrees to provide regular exercise, mental stimulation, adequate grooming, and routine vet checkups for the dog. The Buyer also agrees to not allow the dog's primary residence be outdoors unless otherwise agreed upon.

PAYMENT

The Buyer agrees to pay the total amount stated on page one (1) of the Agreement. Payment to be paid prior to pick up of the dog or at the time of pick up unless otherwise agreed upon in the agreement. If applicable, payment installment terms will be stated on page one (1) of this agreement. The Buyer is responsible for any additional fees, such as fees for transportation, required health certifications, and any other special requests.

LIFETIME RETURN POLICY

If the Buyer can no longer care adequately for the dog, the Buyer agrees to notify the Seller. The Buyer acknowledges that they may not be entitled to a refund. The Buyer should return the dog with any provided documentation and records, including registration papers and health records. The Buyer also agrees not to transfer the dog to a shelter, rescue organization, research facility, or pet store without the Seller's prior written consent. If Buyer is found to have rehomed, sold, or transferred the dog to any shelter, rescue or other third party a penalty of twenty thousand (20,000) dollars will be enforced in court. Buyer will be backlisted from purchasing any animal from Shimmermint LLC, full name will be publicly listed on the ShimmermintSiberians.com website and Breeder will inform it's network of said breach.

No modification, amendment, or alteration of this Agreement shall be binding unless it is made in writing and duly executed by both parties. By signing below, both parties acknowledge and agree to the terms and conditions stated in this 6 page Agreement.
