

Privacy Notice (GDPR)

This Privacy Notice explains how Motley Project ry (“we”, “us”, or “our”) processes personal data in accordance with the General Data Protection Regulation (“GDPR”).

1. Data Controller

2. What personal data we collect

We may collect and process the following personal data:

- Name
- Email address
- Event participation information
- Any other information you voluntarily provide

3. Purpose and legal basis for processing

We process personal data for the following purposes:

- Managing membership and communication
- Organizing events and activities
- Sending newsletters or updates (only if consent is given)

Legal bases for processing:

- Consent (Article 6(1)(a))
- Contract (Article 6(1)(b))
- Legitimate interest (Article 6(1)(f))

4. Data retention

We retain personal data only as long as necessary for the purposes described above or as required by law.

5. Data sharing

We do not sell or rent your personal data. We may share data with:

- Service providers (e.g., email or hosting services)
- Authorities if required by law

All third parties are required to comply with data protection regulations.

6. Your rights

Under GDPR, you have the right to:

- Access your personal data
- Rectify inaccurate data
- Request erasure of your data
- Restrict or object to processing
- Withdraw consent at any time
- Lodge a complaint with a supervisory authority (in Finland: the Office of the Data Protection Ombudsman)

7. Data security

We implement appropriate technical and organizational measures to protect personal data against unauthorized access, loss, or misuse.

8. Cookies

Our website may use cookies to improve user experience. You can control cookie settings through your browser.

9. Use of Images

Images and recordings may be used for:

- Promoting the association's activities (e.g., website, social media, publications)
- Documenting events and workshops

We do not publish names or other identifying personal data of minors together with images without separate explicit consent.

Voluntary participation

Participation in photography and video recording is always voluntary. Individuals (or their guardians) may refuse photography without any impact on participation in activities.

Withdrawal of consent

Consent can be withdrawn at any time by the participant or their parent/guardian. After withdrawal, no new material will be published, and reasonable steps will be taken to remove existing content where possible.

Group and event photography

In group settings or public event environments, we aim to inform participants in advance if photography will take place. We will make reasonable efforts to respect individuals who do not wish to be photographed (e.g., by providing opt-out options or designated no-photo areas).
