ARTICLES OF INCORPORATION

OF

GREEN BRIAR VILLAGE CLUB, INC.

(A corporation not for profit)

The undersigned subscribers and directors hereby file these Articles of Incorporation of the GREEN BRIAR VILLAGE CLUB, INC., pursuant to F.S. 617.02.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the corporation shall be GREEN BRIAR VILLAGE CLUB, INC., herein referred to as the "Club", and it shall have as its principal office 10131 Gifford Boulevard, Orlando, Florida, 32821.

ARTICLE II - PURPOSES AND POWERS

The Club has been formed as a non-profit corporation for the purposes of promoting the recreation, health, safety and welfare of its members, operating the Recreational Facilities not for profit but solely for the mutual advantages of its members, and protecting the values of the Property and Recreational Facilities. As used herein, the "Property" shall mean the land and improvements thereon known as Tract C GREEN BRIAR VILLAGE WILLIAMSBURG AT ORANGEWOOD and described on the Plat thereof as recorded in Plat Book 9, Page 101, Public Records of Orange County, Florida, and "Recreational Facilities" shall mean such land and improvements thereof as may hereafter be deeded to the Club.

The Club will not permit any distribution of its income to its members, officers or directors.

In addition to the powers otherwise provided by law, the

Club shall have the power to:

1. Exercise all of the powers and privileges and perform all of the duties set forth in that certain Declaration of Covenants and Restrictions, herein called the "Declaration", applicable to the Property and recorded in Official Records Book 3140, Page 1541, Public Records of Orange County, Florida, as the same may be amended from time to time as therein provided, the Declaration being incorporated herein as if set forth at length;

2. As provided in the By-Laws, fix, levy, collect and enforce payment by any lawful means of all charges, dues and assessments pursuant to the terms of any agreement made with a member, and to pay all expenses in connection therewith and all office and other expenses incident to the business of the Club, including all licenses, taxes or governmental charges levied or imposed against the property of the Club;

3. Such powers shall include, but not be limited to, the following:

a. Lighting, improvement and beautification of the Recreation Facilities;

b. Garbage collection and trash and rubbish removal for the Club;

c. Providing police protection, night watchmen, guard and gate services but only when and to the extent specifically authorized by the Directors;

d. Repayment of deficits incurred by the Club, if any, in making capital improvements to or upon the Recreation Facilities, and/or furnishing the services and facilities provided herein to or for the members of the Club;

e. Doing any other thing necessary or desirable, in the judgment of the Directors, to keep the Recreation Facilities neat and attractive or to preserve or enhance the value of the

Recreation Facilities, or to eliminate fire, health or safety hazards, or such other activities which in the judgment of the Directors may be of general benefit to the Members;

f. Provide lawn maintenance service to the members of the Club;

g. Own, lease, acquire, build, operate and maintain the Property and Recreation Facilities, and personal property incident thereto; and

h. Contract for and employ persons, firms, corporations or other agents to assist in the management, operation, maintenance and administration of the Club and Recreation Facilities.

4. Borrow money, mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred, with approval by TWO-THIRDS (2/3rds) of the membership.

5. Dedicate, sell or transfer all of the property owned by the Club to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members as evidenced by an instrument executed by TWO-THIRDS (2/3rds) of the members, agreeing to such dedication, sale or transfer, and the same shall be in conformity with the Declaration;

6. Participate in mergers and consolidations with other non-profit organizations organized for the same purposes or annex additional property, provided that such merger, consolidation or annexation shall have the assent of TWO-THIRDS (2/3rds) of the members; and

7. Have and exercise any and all power, rights and privileges which a corporation organized under the non-profit law of

the State of Florida by law, may now or hereafter have or exercise.

ARTICLE III - MEMBERSHIP

Every person or entity who is an owner of record of a fee simple or undivided fee simple interest in any lot in the Property shall be eligible to become a member of the Club, provided that any such person or entity who holds such interest merely as a security for the performance of any obligation shall not be a member.

ARTICLE IV - DURATION

This corporation shall have perpetual existence.

ARTICLE V - BOARD OF DIRECTORS AND OFFICERS

The affairs of the Club shall be managed by a Board of Directors, who shall be elected by and from the members of the Club, as outlined in the By-Laws. The duties of the officers shall be as prescribed in the By-Laws.

The By-Laws of the Club shall be such as may be initially adopted by the Board of Directors and, upon such adoption, shall be deemed incorporated herein by reference.

ARTICLE IX - AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed in writing and endorsed by ten per cent (10%) of the membership and adopted by a TWO-THIRDS (2/3rds) vote of the membership present and voting at a special meeting or regular meeting as provided in the By-Laws.

ARTICLE X - DISSOLUTIONS

Any dissolution of the Club shall be in accordance with the laws governing corporation not for profit of the State of Florida.

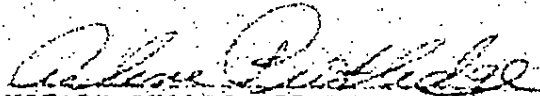
