MESSAGE FROM OUR FOUNDER- KAVITA RAWAT

November was a month of progress, resilience, partnerships, learning, and community engagement for CCSDO. The month unfolded with multiple CSR submissions, strategic meetings, new initiatives, organisation strengthening, and school-level outreach – all aligned with our mission to create meaningful social development impact

CSR & GOVERNMENT PROJECT SUBMISSIONS

A month of preparation, follow-ups, and field coordination

Partnership Application – NCDAP (National Centre for Drug Abuse Prevention), Under NISD (The National Institute of Social Defense)

This project demanded attention due to technical challenges.

The NISD Google link for submission was not functioning, causing delays. To avoid missing the deadline, CCSDO took swift action – the team personally visited the NISD office and submitted the application offline. This showed CCSDO's commitment to accountability, accuracy, and timely delivery – ensuring no barrier stopped us from moving forward.

Project Pragati – Empowerment & Development

Project Pragati was one of CCSDO’s most thoughtfully designed proposals, focused on empowering youth and women. The team studied real community needs and built confidence-based and skill-oriented solutions. Each intervention was crafted carefully to ensure long-term learning and development. After detailed discussions, data collection, and documentation, the proposal was finalised as a strong CSR-aligned model. It was successfully submitted online, marking an important step toward future empowerment initiatives.

Vivo KanyaGyaan – Adolescent Girls’ Awareness Initiative

The Vivo KanyaGyaan project was developed as a thoughtful initiative focused on the needs and wellbeing of adolescent girls. The team designed a safe, informative space for learning about health, hygiene, self-care, and confidence-building. Ground realities and field data were carefully studied to create child-friendly modules. The project became a well-structured blueprint for meaningful adolescent awareness. It was smoothly submitted online, adding a strong contribution to CCSDO’s CSR portfolio and expanding future outreach possibilities.

SBI Foundation – “Garima” (Elderly Care) Proposal

The Garima proposal was submitted to SBI Foundation as a dedicated elderly care initiative. It focuses on emotional wellbeing, healthcare support, and dignity enhancement for vulnerable senior citizens. CCSDO designed the proposal based on ground realities and the needs of neglected elders. The model emphasises care, companionship, and community-based wellbeing services. Its submission marks an important expansion of CCSDO’s social welfare portfolio.

Taksal – Menstrual Hygiene Awareness Proposal

CCSDO submitted a detailed menstrual hygiene proposal to Taksal, targeting adolescent girls. It aims to improve menstrual knowledge, break taboos, and promote safe hygiene practices. The project includes school-based awareness sessions and child-friendly learning tools. It was developed through field insights and discussions with educators and communities. The submission opens new opportunities for expanding menstrual health outreach.

Collaboration with Media & PR Agency – Pratigya

CCSDO’s visibility and outreach will now strengthen through a new engagement with Pratigya – Media & PR Agency, who will support the organisation in communication, branding, and documenting social impact.

Proposal for 4,000 Percolation Pits Project

This month, CCSDO achieved a major milestone by successfully submitting a comprehensive project proposal titled “Implementation of 4,000 Percolation Pits for Water Harvesting & Groundwater Recharge.” The project aims to improve groundwater levels, enhance climate resilience, and strengthen community-based water management systems across targeted rural and peri-urban areas.

INTERNATIONAL COLLABORATION — UNITED NATIONS FORUM (BANGKOK)

CCSDO strengthened its global development footprint by signing an MoU with APSWDP – Association of Professional Social Workers and Development Practitioners during the United Nations Responsible Business and Human Rights (UNRBHR) Forum held in Bangkok.

This collaboration represents a significant step toward enhancing CCSDO’s involvement in international dialogues on responsible development. Through this partnership, CCSDO aims to:

- Expand global engagement and knowledge exchange
- Participate in collaborative research and cross-country development initiatives
- Adopt international best practices in social development
- Strengthen advocacy for responsible and ethical development models

This MoU reinforces CCSDO's commitment to global cooperation and evidence-based development solutions.



ORGANISATIONAL UPDATE — NEW OFFICE LOCATION

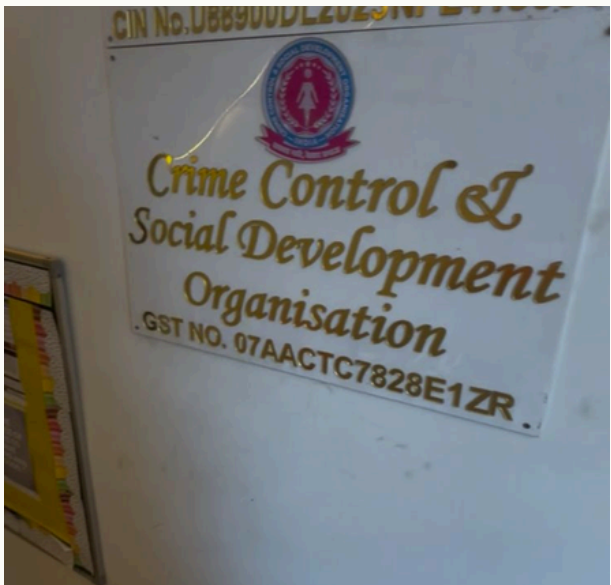
In October, CCSDO transitioned to a larger and more functional office space to support its expanding programs and teams.

मासिक धर्म से संबंधित जानकारी, स्वच्छता और स्वास्थ्य-सुरक्षा के प्रति जागरूकता, विशेषकर किशोरियों एवं छात्राओं के लिए अत्यंत महत्वपूर्ण है। इस कार्यक्रम के माध्यम से छात्राओं को मासिक धर्म के दौरान अपनाई जाने वाली उचित स्वच्छता, स्वास्थ्य एवं सुरक्षा संबंधी वैज्ञानिक जानकारी, सुरक्षित और किफायती विकल्पों, तथा सामाजिक मिथ्याओं, संकोच एवं शिष्टाक्ष को दूर करने के विषय में मार्गदर्शन प्रदान किया जाएगा।

कार्यक्रम के अंतर्गत संगठन छात्राओं को Menstrual Cup के बारे में भी जागरूक करेगा, जो दीर्घकालिक, किफायती, स्वच्छ एवं पर्यावरण के अनुकूल विकल्प है। संगठन अपनी क्षमता अनुसार एवं CSR/सरकारी सहयोग उपलब्ध होने पर इन्हें वितरित करने का भी प्रयास करेगा। यह पहल संयुक्त राष्ट्र के Sustainable Development Goals (SDG 3, 5, 6, 11, 13, 14, 15) के अनुरूप है।


वर्तमान में संगठन केवल निम्नलिखित विद्यालयों में जागरूकता कार्यक्रम संचालित करने की अनुमति चाहता है। कार्यक्रम पूर्ण होने पर संगठन की ओर से एक विस्तृत रिपोर्ट भी विभाग को उपलब्ध कराई जाएगी।
