JB82 Numismatic Expos Terms and Conditions

1. JB82 Numismatic Expos (JBE) reserves the right to refuse space to any applicant and to cancel this contract by refunding fees paid, without recourse or liability on the part of the Exposition or any co-sponsors of this event. JBE also reserves the right to unconditionally reject any application for dealer space for any reason.
2. JBE, at its sole discretion, will assign your Booth(s) location within the bourse floor. Booth(s) location at any given show does not establish a right to the same or any other location at future shows. **Tables will not be assigned until payment in full is made.**
3. No refunds will be made after 60 days prior to the show start date.
4. Only individuals listed on your bourse application or otherwise officially credentialed to your booth and wearing a JBE issued Dealer Badge for this event shall be permitted behind any bourse tables. **Any person working behind a bourse table or issued an employee pass must be a family member or W-2 employee of the registered table holder. There are no exceptions to this rule.** Violation of this rule can result in cancellation of agreement without refund.
5. Applicants are responsible for the conduct of any individual credentialed for their booth. Only individuals credentialed with a JBE issued dealer badge are permitted to do business in, at, and/or from your booth. Any unethical practices or violations of the terms, rules, or conditions will result in immediate cancellation of the table privileges without refund of any monies that may have been paid and expulsion from the event.
6. All dealers and authorized badge holders assume all responsibility, financial or otherwise, for all transactions conducted at the dealer's booth and recognize by signing this application that others have the right to rely on this representation as third party beneficiaries of this agreement. All dealers are individually responsible for complying with local, state, and federal laws with respect to permits and payments.
7. Armed security by local law enforcement and/or a licensed security firm will be on-premises from 7am on Thursday, of the scheduled show, through Saturday 6pm, of the scheduled show. Although security will be furnished, Applicant understands, and is responsible for notifying any individual credentialed for your booth, that such security is provided as an accommodation only and does not constitute: a guarantee against, a policy of insurance, or a promise to indemnify in the event of loss by fire, flood, robbery, theft, or mysterious disappearance. Applicants acknowledge they are responsible, as well as any credentialed for your booth, to obtain their own insurance coverage.
8. Booths not claimed by noon on Thursday, of the scheduled show date, may, at the sole discretion of JBE, revert to reassignment without refund to original applicant. Late arrivals MUST notify JBE by phone prior to noon on Thursday.
9. An offer for sale of any illegal, forged, or counterfeit item including but not limited to bullion, currency, stamps, and historical artifacts without the word "counterfeit" or "copy" prominently and permanently displayed is not allowed. JBE, in its sole discretion may exclude any item including suspected counterfeits. Any violations will result in the immediate suspension of all table privileges and removal from the event.
10. Applicant agrees and acknowledges that failure by JBE to enforce any provision of any term and/or condition of this bourse application shall not be construed to create a waiver and/or modification of any applicant and any credentialed individual obligations pursuant to this and/or any future bourse application.
11. Applicant acknowledges and agrees that the maximum liability of JBE and any or all of its directors, officers, or employees in the aggregate shall not exceed the combined sums paid by Applicant to JBE under this bourse agreement.
12. The applicant hereby releases JB82 Numismatic Expos, the venue listed, and all officers, members or committees in their respective official, individual, or personal capacities from responsibility for any loss, damage, or injury, however sustained, either directly or indirectly, in connection with this event and agrees to defend, indemnify, and hold forever harmless all other parties to this contract. This release, however, shall not limit liability of any individual who may personally be guilty of theft, willful damage, or destruction.
13. In the unlikely event of cancellation of part or all the show, for any reason, recovery is limited to the refund of any fees paid to JBE. This is the entire contract between the parties and there is no other contract between them. This agreement supersedes, voids, and terminates any and all other agreements which may have existed previously, or which may exist at time of signature.
14. All agreement and covenants contained herein are servable, and in the event any of them shall be held to be invalid by any competent Court, this agreement shall be interpreted as if such invalid agreements or covenants were not contained herein. The validity of this agreement, its construction, interpretation, enforcement, and rights of the parties hereto shall be determined under, governed by, and construed in accordance with the laws of the state of Kentucky. The parties agree that all actions or proceedings arising in connection with this agreement shall be tried only in the State or Federal Courts located in Bullitt County, Kentucky.
15. No table applicant will be allowed to set-up and occupy their assigned table until all fees are paid in full.
