# CALL FOR PAPERS



## ELIGIBILITY

## SUBMISSION GUIDELINES

1. Author must submit a maximum 500 words abstract not later than February 20th, 2026 (Friday).
2. Abstract must contain details about the topic, objectives, issues and scope of the area.
3. The cover page should include names of the author(s), contact details, institutional affiliation, and designation.
4. Maximum of 5 keywords are to be provided along with the abstract.
5. Co-authorship is permissible up to three authors for each research paper.
6. Acceptance of the abstracts shall be communicated by February 27th 2026 (Friday).
7. On selection of the abstract, the author(s) must pay the required fees no later than March 20th, 2026 (Friday).
8. Final paper after revision should be submitted by April 10th 2026 (Friday).

## PAPER SUBMISSION GUIDELINES

1. Last date for submission of full paper with plagiarism report (Turnitin) is March 20th, 2026 (Friday).
2. All papers must be submitted through EasyChair
3. The full-length paper should be between 5000 - 8000 words (exclusive of footnotes and references).
4. In case of co-authorship, at least one author must attend the conference to present the paper.
5. The main text should be in Times New Roman with font size 12 and spacing of 1.5.
6. Spelling: UK - except in quoted text, which will follow the original spelling.
7. Pages to be numbered - Bottom of the page, at the center - numbered as 1, 2, 3, etc.
8. Reference: APA 7th Edition with Times New Roman in alphabetical order.
9. Style for headings - Chapter Title: All in caps, bold, centered.
10. Style for subheadings:
  - Level 1: Headline style - capital, bold, left aligned, underlined.
  - Level 2: Headline style - bold, italics, left aligned.
  - Level 3: Headline style - italics, left aligned.
11. Plagiarism: All submissions must be with original and unpublished work. Similarity Index should not exceed 10%.
12. The paper must be submitted in word document (.doc or .docx) format only.
